Registration

How do you register?

To place bids and make purchases, you need to create a personal account. This process is quick, easy, and completely free. Please follow these steps:

- 1. Click the profile icon in the top-right corner of the screen.

- 4. Check your email and confirm your email address.
- 5. Activate your account through phone number verification.

Placing a Bid

How do you place a bid?

- 1. Log into your account.
- 2. Locate the lot you wish to bid on.
- 3. On the right side of the screen, you will see the current bid and bidding history.
- 4. Click 'Check bid' to view the total amount including buyer's fee and VAT.
- 5. Accept the general terms and conditions by ticking the checkbox.
- 6. Click 'Confirm' to place your bid.

Please note!

- Do not enter the euro symbol.
- Do not use a period (.) or trailing zeroes (0) after the decimal.
- You can enter your own bid amount, even if it differs from the suggested next bid.
- Once confirmed, your bid is legally binding.

What is automatic bidding and how does it work?

With automatic bidding, you enter your maximum bid. The platform will automatically place the minimum required increase on your behalf whenever a higher bid is received, until your maximum is reached. You can cancel an automatic bid by placing a fixed bid that becomes the highest bid at that time.

How do you activate automatic bidding?

Use the button below the 'Check bid' option to enable automatic bidding.





Important Notes

- Yachts are sold on an 'As is, Where is' basis. We recommend visiting the yacht on the designated viewing day.
- Your bid is legally binding and cannot be withdrawn.
- You must be logged in to follow the auction in real-time.
- If a bid is placed in the last 3 minutes, the auction will be extended by 3 minutes.
- If we are unable to reach you at the end of the auction, we reserve the right to temporarily block your account from bidding.
- Buyers outside the EU may qualify for VAT-free export.
- Companies within the EU with a valid VAT number (excluding NL) may qualify for 0% VAT under intracommunity trade regulations.
